What is the CPO?

Upon successful completion you will receive certification and registration as a Pool/ Spa Operator valid for five years. The CPO is recognized world wide as the leading training standard of the swimming pool industry. The CPO seal of approval is assurance to commercial pool and spa owners that their facilities and guests are under the care and supervision of a trained professional. Participants are trained in the most advanced techniques of chemical treatment, filtration, and mechanical system operation and maintenance. The curriculum is academically based. University educators with no bias of commercial pool manufacturers or suppliers sponsor these courses.

Who should attend this course?

How can I prepare?
