What is the CPO?

Upon successful completion you will receive certification and registration as a Pool/ Spa Operator valid for five years. The CPO is recognized worldwide as the leading training standard of the swimming pool industry. The CPO seal of approval is assurance to commercial pool and spa owners that their facilities and guests are under the care and supervision of a trained professional. Participants are trained in the most advanced techniques of chemical treatment, filtration, and mechanical system operation and maintenance. The curriculum is academically based. Who should attend this course?

How can I prepare?

If you read the text, pay attention in class, and complete the first day's homework you will probably pass the open-book/open-note exam but a re-take can be scheduled for \$100.00.
